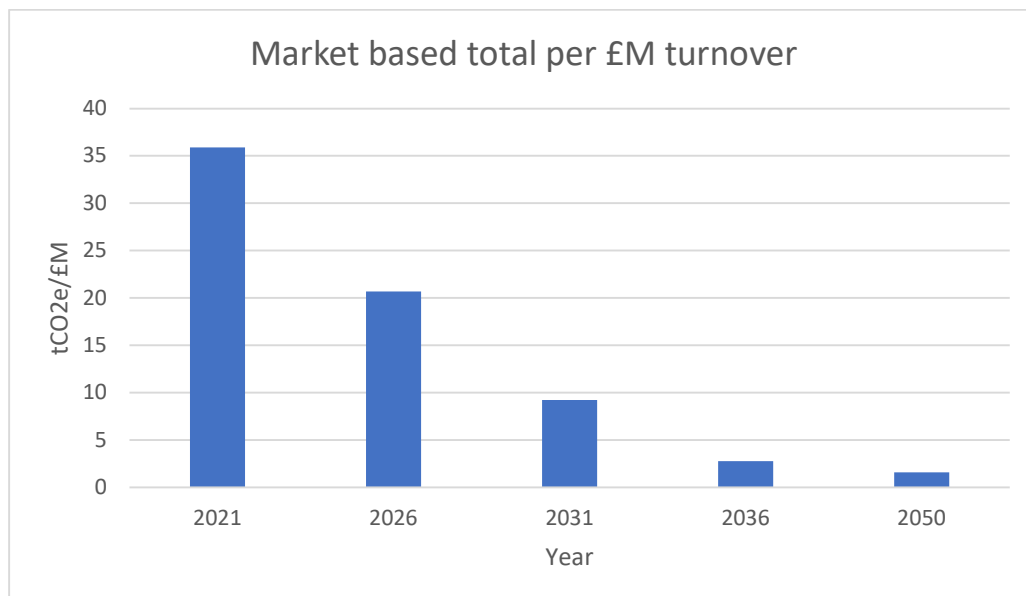

### Emissions reduction targets

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that our carbon emissions per £m turnover, will decrease over the next five years from 35.90 tCO<sub>2</sub>e/£M to 20.67 tCO<sub>2</sub>e/£M by 2026. This is a reduction of 42.4%.

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been implemented since the 2021 baseline.

Within the last calendar year, we have made the following changes which we hope will have an impact on our current emissions.

- Gained ISO 14001:2015 certification
- Changed floor-plate lighting to LED
- Changed all unit electricity to green energy tariffs
- Replaced inefficient boilers with the latest energy efficient alternatives
- Started the Electric Car Scheme
- Upgraded IT hardware for all employees to support working from home where possible
- Encouraged suppliers to consider alternative to air freight where possible (use of sea freight etc)

In the future, we hope to implement further measures such as;

- Continue to reduce waste by exploring more recycling or re-purposing opportunities
- Install additional EV chargers at our Perrywood facility
- Support local green initiative (tree planting etc)
